





DSWD DROMIC Report on the Fire Incident in Brgy. Bawang, San Remigio, Antique

22 March 2024, 6AM

I. Situation Overview

On March 15, 2024, a residential fire broke out around 7:20 PM in Barangay Bawang, San Remigio, Antique, caused by a faulty electrical wire. One (1) house was reported completely destroyed, displacing a family of two (2) individuals. The affected family sought shelter with relatives, and the fire was extinguished by around 8:35 PM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of San Remigio, Antique, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in Brgy. Bawang, San Remigio, Antique (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bawang, San Remigio, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P10,865.78** worth of assistance was provided to the affected family composed of **P5,865.78** from the **DSWD** and **P5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
