I. Situation Overview

On 10 March 2024 at around 10PM, a fire incident occurred in Brgy. Bitag-og Gaja, New Lucena, Iloilo. The fire was declared out at around 10:40 PM.

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bitag-og, Gaja, New Lucena, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,416.00** worth of assistance was provided to the affected families; of which, **₱8,416.00** from **DSWD** and **₱1,000.00** from the **Local Government Unit (LGU)** (see Annex D).
