I. Situation Overview

On 29 February 2024 at around 12:10 PM, a fire incident occurred at Brgy. Bugo, San Remigio, Antique. The fire was declared out at around 01:43 PM.

One (1) house was **totally damaged** in **Brgy. Bugo, San Remigio, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,865.78** worth of assistance was provided to the affected family; of which, **₱5,865.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
