I. Situation Overview

On 19 March 2024 at around 11:23 PM, a fire incident occurred in Brgy. Bulanao, Tabuk City, Kalinga.

II. Status of Affected Areas and Population

A total of **four (4) families** or **17 persons** were affected in **Brgy. Bulanao, Tabuk City, Kalinga** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **17 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Bulanao, Tabuk City, Kalinga** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱196,730.48** worth of assistance was provided to the affected families; of which, **₱133,172.60** from **DSWD**, **₱3,488.00** from the **Local Government Unit (LGU)**, **₱23,200.00** from the **Non-Government Organizations (NGO)**, and **₱36,909.88** from **Other Partners** (see Annex D).
