





DSWD DROMIC Report on the Fire Incident in Brgy. Cabadiangan, Himamaylan City, Negros Occidental

28 February 2024, 6AM

I. Situation Overview

On 25 February 2024 at around 3:00 PM, a fire incident occurred at Brgy. Cabadiangan, Himamaylan, Negros Occidental. The fire was declared out at around 4:18 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Himamaylan City, Negros Occidental, actively engaged in the response operation and promptly provided relief and financial assistance to support the immediate needs of the affected families and individuals.

One (1) family or four (4) persons were affected in Brgy. Cabadiangan, Himamaylan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Cabadiangan, Himamaylan City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}18,425.78\$ worth of assistance was provided to the affected families; composed of \$\mathbb{P}8,425.78\$ from the DSWD and \$\mathbb{P}10,000.00\$ from the Local Government Unit (LGU) (see Annex D).
