I. Situation Overview

On 06 February 2024 at around 1:30 PM, a fire incident occurred in Brgy. Cabayogan, Badiangan, Iloilo. The fire was declared out at around 2:00 PM.

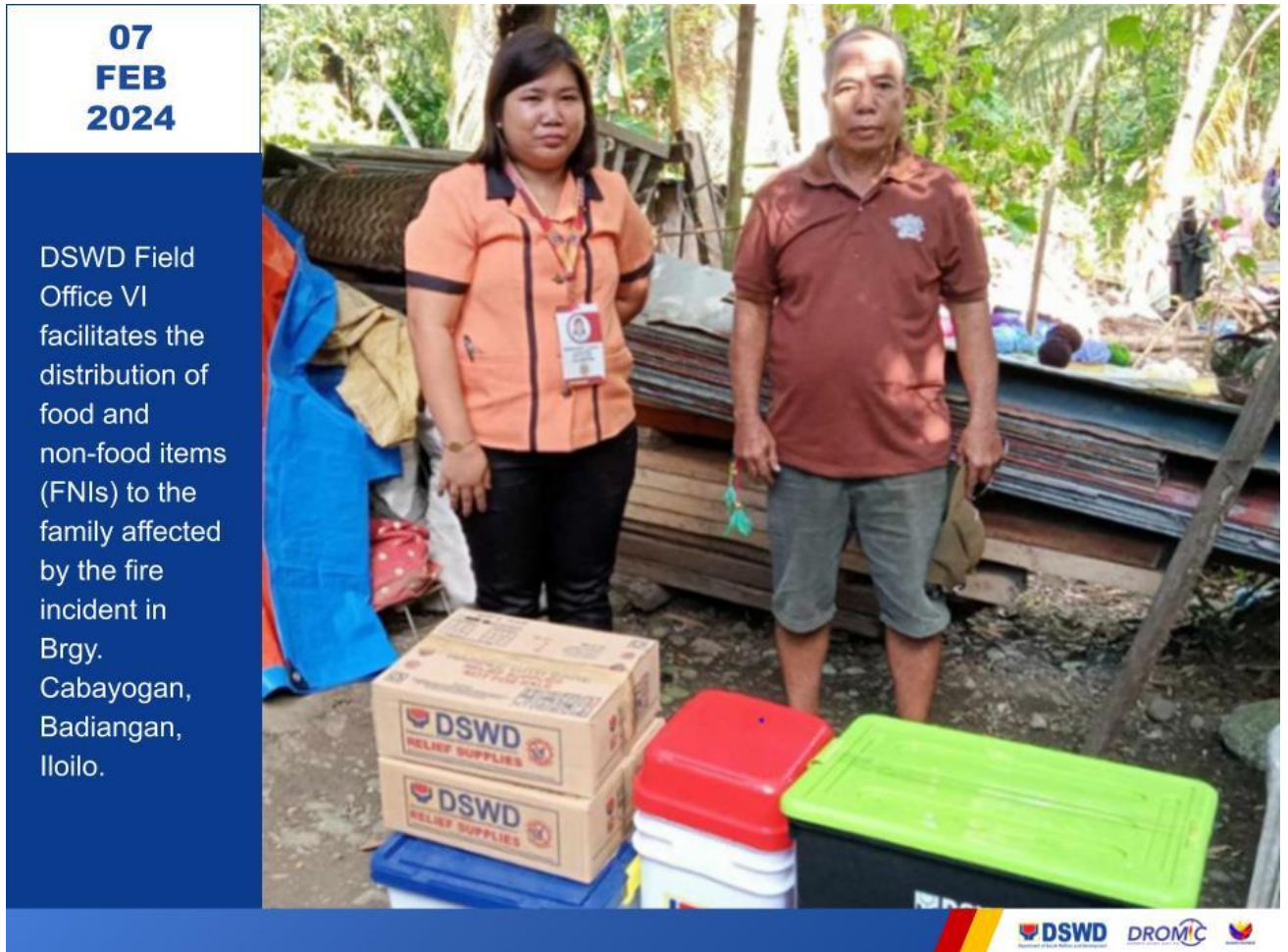
