I. Situation Overview

On 06 February 2024 at around 1:30 PM, a fire incident occurred in Brgy. Cabayogan, Badiangan, Iloilo. The fire was declared out at around 2:00 PM.

One (1) house was totally damaged in Brgy. Cabayogan, Badiangan, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,146.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
