



DSWD DROMIC Report on the Fire Incident in Brgy. Cabug, Bacolod City, Negros Occidental

07 March 2024, 6AM

I. Situation Overview

On 03 March 2024 at around 3:30 PM, a fire incident occurred at Brgy. Cabug, Bacolod City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was faulty electrical wiring. The fire was declared out at around 4:50 PM.

In response, the DSWD through its Field Office in Region VI distributed food and nonfood items to the affected family.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in Brgy. Cabug, Bacolod City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (2) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Cabug, Bacolod City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱11,218.00 worth of assistance was provided to the affected family composed of ₱6,928.00 from the DSWD and ₱4,290.00 from the Non-Government Organization (NGO) (see Annex D).
