

DSWD DROMIC Report on the Fire Incident in Brgy. Cabug, Bacolod City, Negros Occidental

07 March 2024, 6AM

I. Situation Overview

On 03 March 2024 at around 3:30 PM, a fire incident occurred at Brgy. Cabug, Bacolod City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was faulty electrical wiring. The fire was declared out at around 4:50 PM.

In response, the DSWD through its Field Office in Region VI distributed food and non-food items to the affected family.

One (1) family or two (2) persons were affected in **Brgy. Cabug, Bacolod City, Negros Occidental** (see Annex A).

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabug, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,218.00** worth of assistance was provided to the affected family composed of **₱6,928.00** from the **DSWD** and **₱4,290.00** from the **Non-Government Organization (NGO)** (see Annex D).
