

DSWD DROMIC Report on the Fire Incident in Brgy. Cabugao, Altavas, Aklan

23 March 2024, 6AM

I. Situation Overview

On March 11, 2024, at around 7:45 PM, a fire incident transpired in Sitio Amiligan Barangay Cabugao, Altavas, Aklan. The incident left one (1) house totally damaged displacing one (1) family equivalent to four (4) persons who temporarily stayed with their relatives.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Altavas, Aklan, promptly provided relief assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **four (4) persons** were affected in **Brgy. Cabugao, Altavas, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabugao, Altavas, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,368.00** worth of assistance was provided to the affected family composed of **₱6,648.00** from **DSWD** and **₱5,720.00** from the **Local Government Unit (LGU)** (see Annex D).
