

## **DSWD DROMIC Report on the Fire Incident in Brgy. Calumpang, General Santos City**

28 February 2024, 6AM

### **I. Situation Overview**

On 18 February 2024 at around 4:55 PM, a fire incident occurred at Prk. Saeg, Barangay Calumpang, General Santos City.

Relative to the incident, the DSWD through its Field Office in Region XII, provided relief augmentation to support the immediate needs of the affected families and individuals.
