
DSWD DROMIC Report on the Fire Incident in Brgy. Camingawan, Kabankalan City, Negros Occidental

13 March 2024, 6PM

I. Situation Overview

On 06 March 2024 at around 4:30 AM, a fire incident occurred in Brgy. Camingawan, Kabankalan City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to a faulty electrical wire. The fire was declared out at around 6:10 AM.

One (1) family or **eight (8) persons** were affected in **Brgy. Camingawan, Kabankalan City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Camingawan, Kabankalan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,927.78** worth of assistance was provided to the affected family; of which, **₱6,927.78** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
