

## **DSWD DROMIC Report on the Fire Incident in Brgy. Carabalan, Himamaylan City, Negros Occidental**

13 March 2024, 6PM

### **I. Situation Overview**

On 25 February 2024 at around 4PM, a fire incident occurred in Brgy. Carabalan, Himamaylan City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to a faulty electrical wire. The fire was declared out at around 5:15 PM.

**One (1) family or four (4) persons** were affected in **Brgy. Carabalan, Himamaylan City, Negros Occidental** (see Annex A).

**One (1) family or four (4) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Carabalan, Himamaylan City, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱18,425.78** worth of assistance was provided to the affected family; of which, **₱8,425.78** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
