





DSWD DROMIC Report on the Fire Incident in Brgy. Carabalan, Himamaylan City, Negros Occidental

13 March 2024, 6PM

I. Situation Overview

On 25 February 2024 at around 4PM, a fire incident occurred in Brgy. Carabalan, Himamaylan City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to a faulty electrical wire. The fire was declared out at around 5:15 PM.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Carabalan, Himamaylan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Carabalan, Himamaylan City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱18,425.78 worth of assistance was provided to the affected family; of which, ₱8,425.78 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
