





DSWD DROMIC Report on the Fire Incident in Brgy. Cari Minor, Leganes, Iloilo

23 March 2024, 6AM

I. Situation Overview

On 29 February 2024 at around 2:24 PM, a fire incident occurred at Brgy. Cari Minor, Leganes, Iloilo. The fire was declared out at around 3:00 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Leganes, Iloilo promptly provided relief assistance to support the immediate needs of the affected person.

One (1) person was affected in Brgy. Cari Minor, Leganes, Iloilo (see Annex A).

One (1) person temporarily stayed with relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Cari Minor, Leganes, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}9,714.00\$ worth of assistance was provided to the affected person composed of \$\mathbb{P}8,514.00\$ from the **DSWD** and \$\mathbb{P}1,200.00\$ from the **Local Government Unit (LGU)** (see Annex D).
