I. Situation Overview

On 10 February 2024 at around 6:00 AM, a fire incident occurred at Sitio Proper, Brgy. Cawayan, Asipulo, Ifugao.

V. Cost of Humanitarian Assistance Provided

A total of **₱20,696.50** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
