





DSWD DROMIC Report on the Fire Incident in Brgy. Don Roque Ablan Sr., Calanasan, Apayao

06 March 2024, 6AM

I. Situation Overview

On 25 January 2024 at around 12:00 PM, a fire broke out at Brgy. Don Roque Ablan Sr., Calanasan, Apayao, resulting in one (1) family or three (3) individuals affected with partial damage to their house.

In response, the DSWD through its Field Office in Region VII, together with the Local Government Unit (LGU) of Calanasan, Apayao, promptly provided relief and financial assistance to support the immediate needs of the affected family.

A total of **One (1) family** or **three (3) persons** were affected in **Brgy. Don Roque Ablan Sr., Calanasan, Apayao.** (see Annex A).

III. Damaged Houses

One (1) house was partially damaged in Brgy. Don Roque Ablan Sr., Calanasan, Apayao. (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **P56,799.45** worth of assistance was provided to the affected families; of which, **P16,799.45** from **DSWD** and **P40,000.00** from the **Local Government Unit (LGU)** (see Annex C).
