I. Situation Overview

On 18 February 2024 at around 12:30 PM, a fire incident occurred at Brgy. Fortuna, Marcos, Ilocos Norte.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Fortuna, Marcos, Ilocos Norte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house is totally damaged in Brgy. Fortuna, Marcos, Ilocos Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P35,197.25** worth of assistance was provided to the affected families; of which, **P20,197.25** from **DSWD** and **P15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
