





# DSWD DROMIC Report on the Fire Incident in Brgy. Handumanan, Bacolod City, Negros Occidental 20 March 2024. 6PM

## I. Situation Overview

On 11 March 2024 at around 3:30 PM, a fire incident occurred in Brgy. Handumanan, Bacolod City, Negros Occidental. The fire was declared out at around 4:50 PM.

A total of **two (2) families** or **seven (7) persons** were affected in **Brgy. Handumanan**, **Bacolod City** (see Annex A).

# III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Handumanan, Bacolod City** (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P22,436.00** worth of assistance was provided to the affected families; of which, **P13,856.00** from **DSWD** and **P8,580.00** from the **Local Government Unit** (**LGU**) (see Annex D).
