I. Situation Overview

On 16 March 2024 at around 3:32 PM, a fire incident occurred at Sitio Tubutan in Brgy. Igtambo, San Miguel, Iloilo.

Outside Evacuation Center

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Igtambo, San Miguel, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,832.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
