## I. Situation Overview

## V. Cost of Humanitarian Assistance Provided

A total of **₱23,634.00** worth of assistance was provided to the affected family; of which, **₱18,634.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
