## DSWD DROMIC Report on the Fire Incident in Brgy. Jayubo, Lambunao, Iloilo

26 March 2024, 6AM

### I. Situation Overview

On 20 March 2024 at around 10:00 AM, a fire incident occurred at Sitio Udyang, Brgy. Jayubo, Lambunao, Iloilo. The fire was declared out at around 10:40 AM.

### II. Status of Affected Areas and Population

A total of **five (5) families** or **26 persons** were affected in **Brgy. Jayubo, Lambunao, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **five (5) families** or **26 persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **five (5) houses** were damaged; of which, **four (4) are totally damaged** and **one (1) was partially damaged** in **Brgy. Jayubo, Lambunao, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱84,020.00** worth of assistance was provided to the affected families; of which, **₱41,220.00** from **DSWD** and **₱42,800.00** from the **Local Government Unit (LGU)** (see Annex D).
