I. Situation Overview

On 19 February 2024 at around 1:40 PM, a fire incident occurred in Brgy. Kinabuan, Dupax del Sur, Nueva Vizcaya.

One (1) family or four (4) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Kinabuan, Dupax del Sur, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱21,603.00** worth of assistance was provided to the affected families; of which, **₱14,603.00** from **DSWD** and **₱7,000.00** from the **Local Government Unit (LGU)** (see Annex D).
