I. Situation Overview

On 21 January 2024 at around 12:00 PM, a fire incident occurred in Brgy. Malekkeg, Santa Marcela, Apayao.

One (1) family or three (3) persons were affected in Brgy. Malekkeg, Santa Marcela, Apayao (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Malekkeg, Santa Marcela, Apayao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱52,115.70 worth of assistance was provided to the affected families; of which, ₱22,115.70 from DSWD and ₱30,000.00 from the Local Government Unit (LGU) (see Annex D).
