





DSWD DROMIC Report on the Fire Incident in Brgy. Matapay, Hilongos, Leyte

18 March 2024, 6AM

I. Situation Overview

On 05 March 2024 at around 1:30 PM, a fire incident occurred in Brgy. Matapay, Hilongos, Leyte.

Relative to the incident, the DSWD through its Field Office in Region VIII, promptly provided relief augmentation to support the immediate needs of the affected families and individuals.

One (1) house was totally damaged in Brgy. Matapay, Hilongos, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱8,201.50 worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
