### I. Situation Overview

On 21 January 2024 at around 6:35 PM, a fire incident occurred at Brgy. Nibaliw Norte, Bautista, Pangasinan.

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Nibaliw Norte, Bautista, Pangasinan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱23,745.50** worth of assistance was provided to the affected families; of which, **₱22,735.50** from **DSWD** and **₱1,010.00** from the **Local Government Unit (LGU)** (see Annex D).
