I. Situation Overview

On 21 January 2024 at around 6:35 PM, a fire incident occurred at Brgy. Nibaliw Norte, Bautista, Pangasinan.

Outside Evacuation Center

One (1) family or two (2) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Nibaliw Norte, Bautista, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱23,745.50 worth of assistance was provided to the affected families; of which, ₱22,735.50 from DSWD and ₱1,010.00 from the Local Government Unit (LGU) (see Annex D).
