## DSWD DROMIC Report on the Fire Incident in Brgy. Nueva Invencion, Barotac Viejo, Iloilo

26 March 2024, 6AM

### I. Situation Overview

On 19 March 2024 at around 9:00 AM, a fire incident occurred at Sitio Bangon-Bangon, Brgy. Nueva Invencion, Barotac Viejo, Iloilo. The fire was declared out at around 9:15 AM.

**One (1) family** or **three (3) persons** are affected in **Brgy. Nueva Invencion, Barotac Viejo, Iloilo** (see Annex A).

**One (1) family** or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Nueva Invencion, Barotac Viejo, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,856.00** worth of assistance was provided to the affected families; of which, **₱5,856.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
