I. Situation Overview

On 14 March 2024 at around 9:35 AM, a fire incident occurred at Brgy. Paguraper, Santo Domingo, Ilocos Sur.

One (1) family or six (6) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Paguraper, Santo Domingo, Ilocos Sur (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,701.52** worth of assistance was provided to the affected families; of which, **₱10,000.00** from **DSWD** and **₱701.52** from the **Local Government Unit (LGU)** (see Annex D).
