I. Situation Overview

On 10 March 2024 at around 1:03 PM, a fire incident occurred in Brgy. Palaciawan, Barotac Nuevo, Iloilo. The fire was declared out at around 1:30 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Palaciawan, Barotac Nuevo, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,416.00** worth of assistance was provided by **DSWD** to the affected family and individuals (see Annex D).
