





DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion 01, Lawaan, Eastern Samar

11 March 2024, 6AM

I. Situation Overview

On 29 February 2024 at around 09:00 AM, a fire incident occurred at Brgy. Poblacion 01, Lawaan, Eastern Samar. The fire was declared out at around 09:30 AM.

Relative to the incident, the DSWD through its Field Office in Region VIII, promptly provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

A total of **two (2) families** or **nine (9) persons** were affected in **Barangay Poblacion 01, Lawaan, Eastern Samar** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **nine (9) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged composed of **one (1) totally damaged** and **one (1) partially damaged** in **Brgy. Poblacion 01, Lawaan, Eastern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P17,399.62** worth of assistance was provided by the **DSWD** to the affected families. (see Annex D).
