

## **DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion Ilawod, City of Passi, Iloilo**

11 March 2024, 6AM

### **I. Situation Overview**

On 24 January 2024 at around 10:30 AM, a fire incident occurred in Brgy. Poblacion Ilawod, City of Passi, Iloilo. The fire was declared out at around 11:20 AM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Passi City, provided relief augmentation to support the immediate needs of the affected individual.

**One (1) family or three (3) persons** were affected in **Brgy. Poblacion Ilawod, City of Passi, Iloilo** (see Annex A).

**One (1) family or three (3) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Poblacion Ilawod, City of Passi, Iloilo** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱33,146.00** worth of assistance was provided to the affected family composed of **₱8,146.00** from the **DSWD** and **₱ 25,000.00** from the **Local Government Unit (LGU)** (see Annex D).
