I. Situation Overview

On 11 February 2024 at around 4:38 PM, a fire incident occurred in Brgy. Sambag Culob, Anilao, Iloilo. The fire was declared out at around 5:00 PM.

One (1) family or two (2) persons sought temporary shelter at the Barangay Hall in Brgy. Sambag Culob, Anilao, Iloilo (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Sambag Culob, Anilao, Iloilo (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of ₱8,425.78 worth of assistance was provided by the **DSWD** to the affected families (see Annex E).
