

DSWD DROMIC Report on the Fire Incident in Brgy. San Jose, San Miguel, Iloilo

07 March 2024, 6AM

I. Situation Overview

On 05 March 2024 at around 9AM, a fire incident occurred in Brgy. San Jose, San Miguel, Iloilo. The fire was declared out at around 9:25 AM.

In response, the DSWD through its Field Office in Region VI provided relief assistance to support the immediate needs of the displaced individual.
