





DSWD DROMIC Report on the Fire Incident in Brgy. Sta. Cruz, City of Koronadal, South Cotabato

29 February 2024, 6PM

I. Situation Overview

On 22 February 2024 at around 12:02 PM, a fire incident occurred at Purok Masipag, Brgy. Sta. Cruz, City of Koronadal, South Cotabato. The fire was declared out at around 12:46 PM.

II. Status of Affected Areas and Population

A total of 10 families or 50 persons were affected in Brgy. Sta. Cruz, City of Koronadal, South Cotabato (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **10 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Sta. Cruz, Koronadal City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P35,612.00** worth of assistance was provided to the affected families; of which, **P29,112.00** from **DSWD** and **P6,500.00** from the **Local Government Unit (LGU)** (see Annex D).
