

## **DSWD DROMIC Report on the Fire Incident in Brgy. Suklayin, Baler, Aurora**

21 March 2024, 6AM

### **I. Situation Overview**

On March 15, 2024, at 12:00 PM, a fire broke out in Brgy. Suklayin, Baler, Aurora, resulting in the total destruction of one house and the displacement of one family. The affected family is currently residing with relatives.

Relative to the incident, the DSWD through its Field Office in Region III provided financial assistance to support the family's daily subsistence needs. Likewise, the Local Government Unit (LGU) of Baler, Aurora, distributes relief goods composed of food and non-food items.
