

DSWD DROMIC Report on the Fire Incident in Brgy. Sum-ag, Bacolod City, Negros Occidental

23 March 2024, 6AM

I. Situation Overview

On 16 March 2024 at around 4:20 PM, a fire incident occurred in Brgy. Sum-ag, Bacolod City, Negros Occidental. The fire was declared out at around 5:15 PM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Bacolod City, promptly provided relief assistance to support the immediate needs of the affected family.

One (1) family or four (4) persons were affected in **Brgy. Sum-ag, Bacolod City, Negros Occidental** (see Annex A).

III. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Sum-ag, Bacolod City, Negros Occidental** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱11,218.00** worth of assistance was provided to the affected family composed of **₱6,928.00** from the **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex C).
