I. Situation Overview

On 02 January 2024 at around 10PM, a fire incident occurred in Brgy. Tebag, Mangaldan, Pangasinan.

II. Status of Affected Areas and Population

A total of **three (3) families** or **12 persons** were affected in **Brgy. Tebag, Mangaldan, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **three (3) families** or **12 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Tebag, Mangaldan, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱31,476.00** worth of assistance was provided to the affected families; of which, **₱16,476.00** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
