





# DSWD DROMIC Report on the Fire Incident in Brgy. Tinampa-an, Cadiz City, Negros Occidental

13 March 2024, 6PM

#### I. Situation Overview

On 05 March 2024 at around 12:30 PM, a fire incident occurred in Brgy. Tinampa-an, Cadiz City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to an unattended firewood stove. The fire was declared out at around 2:10 PM.

One (1) family or three (3) persons were affected in Brgy. Tinampa-an, Cadiz City, Negros Occidental (see Annex A).

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tinampa-an, Cadiz City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱18,786.00 worth of assistance was provided to the affected family; of which, ₱7,086.00 from DSWD and ₱11,700.00 from the Local Government Unit (LGU) (see Annex D).
