

DSWD DROMIC Report on the Fire Incident in Brgy. Trinidad, San Remigio, Antique

13 March 2024, 6PM

I. Situation Overview

On 07 March 2024 at around 4:30 PM, a fire incident occurred in Brgy. Trinidad, San Remigio, Antique. According to the Bureau of Fire Protection, the cause of fire was allegedly due to faulty electrical wire. The fire was declared out at around 5:25 PM.

One (1) family or three (3) persons were affected in **Brgy. Trinidad, San Remigio, Antique** (see Annex A).

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Trinidad, San Remigio, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,865.78** worth of assistance was provided to the affected family; of which, **₱5,865.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
