### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Tukucan, Tinic, Ifugao** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱56,971.45 worth of assistance was provided to the affected families; of which, ₱16,971.45 from DSWD, ₱30,000.00 from the Local Government Unit (LGU) and ₱10,000.00 from other stakeholders (see Annex D).
