I. Situation Overview

On 15 February 2024 at around 7:00 PM, a fire incident occurred in Brgy. Tukucan, Tinoc, Ifugao.

II. Status of Affected Areas and Population

One (1) family or **seven (7) persons** were affected in **Brgy. Tukucan, Tinic, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tukucan, Tinic, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱56,971.45 worth of assistance was provided to the affected families; of which, ₱16,971.45 from DSWD, ₱30,000.00 from the Local Government Unit (LGU) and ₱10,000.00 from other stakeholders (see Annex D).
