I. Situation Overview

On 15 February 2024 at around 7:00 PM, a fire incident occurred in Brgy. Tukucan, Tinoc, Ifugao.

II. Status of Affected Areas and Population

One (1) family or seven (7) persons were affected in **Brgy. Tukucan, Tinoc, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tukucan, Tinoc, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱56,971.45** worth of assistance was provided to the affected families; of which, **₱16,971.45** from **DSWD**, **₱30,000.00** from the **Local Government Unit (LGU)** and **₱10,000.00** from **other stakeholders** (see Annex D).
