





# DSWD DROMIC Report on the Fire Incident in Brgy. Upper Glad I, Midsayap, North Cotabato

20 March 2024, 6PM

#### I. Situation Overview

On 13 March 2024 at around 8PM, a fire incident occurred in Brgy. Upper Glad I, Midsayap, North Cotabato.

Relative to the incident, the DSWD through its Field Office in Region XII, together with the Local Government Unit (LGU) of Midsayap, North Cotabato, provided relief augmentation to support the immediate needs of the affected families and individuals.

One (1) family or five (5) persons were affected in Brgy. Upper Glad I, Midsayap, North Cotabato (see Annex A).

One (1) family or five (5) persons temporarily staying with their relatives (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Upper Glad I, Midsayap, North Cotabato (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P11,852.80** worth of assistance was provided to the affected family composed of **P9,064.00** from the **DSWD** and **P2,788.80** from the **Local Government Unit (LGU)** (see Annex D).
