

DSWD DROMIC Report on the Fire Incident in Brgy. Villamonte, Bacolod City, Negros Occidental

23 March 2024, 6AM

I. Situation Overview

On March 19, 2024, at around 8:00 PM, a residential fire occurred in Barangay Villamonte, Bacolod City in Negros Occidental. The incident left one (1) totally damaged house and displaced two (2) families equivalent to four (4) persons who temporarily sought shelter with relatives

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Bacolod City, promptly provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **two (2) families** or **four (4) persons** were affected in **Brgy. Villamonte, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Villamonte, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,436.00** worth of assistance was provided to the affected families Composed of **₱13,856.00** from the **DSWD** and **₱8,580.00** from the **Local Government Unit (LGU)** (see Annex D).
