

DSWD DROMIC Report on the Fire Incident in Brgy. Walang, Lambunao, Iloilo

22 March 2024, 6AM

I. Situation Overview

On 10 March 2024 at around 8:00 PM, a fire incident occurred at Sitio Kapahuan, Brgy. Walang, Lambunao, Iloilo. One (1) house was reported completely destroyed, displacing a family of five (5) individuals. The affected family sought shelter with relatives, and the fire was extinguished by around 8:40 PM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Lambunao, Iloilo, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in **Brgy. Walang, Lambunao, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Walang, Lambunao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,204.00** worth of assistance was provided to the affected family composed of **₱8,244.00** from the **DSWD** and **₱5,960.00** from the **Local Government Unit (LGU)** (see Annex D).
