

# DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Bagolibas, Aleosan, North Cotabato

18 March 2024, 6AM

## I. Situation Overview

On 04 March 2024 at around 12:30 PM, an armed conflict between two (2) warring groups transpired within the boundaries of Sitio Tubak, Brgy. Pangan and Purok 8, Brgy. Bagolibas in Aleosan, North Cotabato. The incident resulted in the displacement of families and individuals in the community and left one member of the Moro Islamic Liberation Front (MILF) 118th Base Command wounded.

In response to the incident, the DSWD through its Field Office in Region XII, promptly provided relief augmentation to support the immediate needs of the affected families and individuals.
