

DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Lagandang, Isulan, Sultan Kudarat

29 January 2025, 6AM

I. Situation Overview

On 11 March 2024 at around 6:10 AM, an armed conflict transpired at Purok 7, Brgy. Lagandang, Isulan, Sultan Kudarat between two (2) alleged members of the Moro Islamic Liberation Front (MILF) armed groups also known as "Commander Stallon" and "Commander 05", which resulted in the displacement of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **320 families or 992 persons** were affected in **Brgy. Lagandang, Isulan, Sultan Kudarat** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **320 families or 992 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱220,385.00** worth of assistance was provided to the affected families; of which, **₱218,785.00** from **DSWD** and **₱1,600.00** from the **Local Government Unit (LGU)** (see Annex C).
