





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 51, Tacloban City

06 April 2024, 6AM

I. Situation Overview

On 20 March 2024 at around 3:50 AM, a fire incident occurred at Brgy. 51-Magallanes, Tacloban City, Leyte.

The incident has led to displacement of families and individuals who have now safely returned to their respective homes. Fire out was declared on the same day with the immediate response of the Fire Protection Unit leading to no injuries or casualties.

In response, the DSWD through its Field Office in Region VIII, provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **26 families** or **111 persons** were affected in **Brgy. 51, Tacloban City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **24 families** or **83 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **13 houses** were **totally damaged** in **Brgy. 51, Tacloban City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P660,116.00** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
