

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Cansomoroy, Balamban, Cebu

01 February 2025, 6AM

## I. Situation Overview

On 25 March 2024 at around 11:28 AM, a fire incident occurred in Brgy. Cansomoroy, Balamban, Cebu. The fire was declared out at around 12:10 PM.

**One (1) family or five (5) persons** temporarily stayed with their relatives (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Cansomoroy, Balamban, Cebu** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱19,882.50** worth of assistance was provided to the affected family; of which, **₱6,482.50** from **DSWD** and **₱13,400.00** from the **Local Government Unit (LGU)** (see Annex D).
